Jhajha, Pin - 811 308, District-Jamui within the state of Bihar hereinafter called or referred to as "SETTLOR" AND WHEREAS the settler desirous of setting-up a Public Charitable Trust extensively contacted, approached and discussed the matter with several like minded people of Jhajha town and moved by over whelming response and, therefore, ultimately decided to create this public Charitable Trust for the objects and purposes specified here in after with a sum of rupees ten thousand one only. whole or in part for any purpose other than charitable and/or religious purpose provided further that -

The object of the Trust as enumerated hereinabove are subjects to the condition that in case any of these objects is treated as not charitable proposo within the meaning of the income. tax, wealth-tax and/or other tax laws at any time, as a result where of any income wealth or property of the trust cannot avail the exemption under such tax laws, then the objects of the trust shall not include any such object or purpose and the trustees shall apply the income, funds or property for such objects which are considered charitable.

GENERAL BODY :-

(4) The general body of this trust shall be constituted by or composed of all persons of the following categories also called members viz :

"A" Group:- Each of the founder trustees named here in above.

"B" Group :- Life Member : Two persons seeking membership and giving a donation of Rs. 25,000/- or more and accepted by the Trustees as such, and

"C" Group - Co- Opted trustees upto five persons as such.

PROVIDED also that membership of group "A" shall comprise of PERMANENT TRUSTEE namely Mr. Minnatullah Akhtar and three life time Trustees namely (i) Md. Qamrul Hoda, (ii) Mr. Yogendra Raut, (iii) Mr. Jawed Akhtar.

But member of group "B" will be life member (i. e. for the life time of such members) only, where as members of Group "C" will be members for three years only. For members of Group "C" period of membership shall deemed to be commenced from the date of the Annual General meeting immediately following his becoming of the member and shall deemed to end from the end of the 4th consecutive Annual General meeting held after his becoming of the member.

(5) Each member of any category shall be entitled to attend meetings of the general body and to cast one vote if any and when needed.



In such Annual General Meeting:-

(a) the Audited Accounts of the Trust for immediately past year with Annual Report of the working of the trust will be placed for consideration and adoption,

(b) The election of the trustees to fill in the vacancies caused by "Retiring Trustees" every third year according to the provisions contained herein after, will be held; and

(c) Any other matter presented by the permission of the chair will be considered.





(10) A permanent trustee shall not be liable to retire and shall continue to act as trustee. Any vacancy in the office of permanent trustee after his death, physical or mental infirmity shall be filled in by his nominee or in the absence of any nomination by his wife or in the absence or incapability or death or infirmity of his wife by his eldest living male descendent.

(11) All life time trustees shall not be liable to retire and shall continue to act as trustees till his life time only or until he ceases to be a trustee or becomes disqualified to act as a trustee for any of the reasons here in after specified in this behalf.

ELECTED TRUSTEES :-

(12) The above named Founder trustees will, in the first instance nominate co-opt trustees representing the different group of members of the General Body. Such trustees will retire at the third Annual General meeting of the General Body and in their place new trustees shall be elected in requisite number from the Electoral Groups as mentioned herein above. Provided that any such retiring Trustee will be eligible and may be re-elected. The process of such election will be prescribed by the Board of Trustees in its meeting.

Co-opted TRUSTEES :-

(13) The trustees for the time being at their discretion may co-opt Upto five persons (not necessarily members of General Body) considered useful or beneficial for the purpose and programmes of the Trust. Such co-opted Trustees being full fledged Trustees shall also have same rights and privileges as a member of the General body. The tenure of a co-opted Trustee shall be three years but he/she be eligible for re-nomination.

(14) Subject to other provision contained herein a Trustee shall be disqualified or ceased to be Trustee or may be removed as such on happening of any of the following events by decision of the Board of Trustees:-



- (a) Death,
- (b) Resignation,
- (c) Physical or mental infirmity,
- (d) On failure to attend without leave of absence in five consecutive meetings of Board of Trustees held with twelve months;
- (e) If remains absent from India for a period of more than three years without sanction of the Board of Trustees, or
- (f) On acting against the interest of the Trust, failure to discharge his duties as Trustee as assigned by the Board or to misappropriate the Trust fund,
- (g) On being adjudged insolvent, or
- (h) On being convicted in a court of law for any offence involving moral turpitude.

PROVIDED that the Board of Trustees may by votes of two-third of its total number of Trustees, excluding the Trustee proposed to be removed under clause (d) to (h) above, may remove the Trustee concerned only after allowing that Trustee a fair and full opportunity for explaining his conduct and/or charges levelled against him for removal and such decision of the Board of Trustees shall be final and binding and shall not be disputed or challenged anywhere or in courts.

(15) If and whenever any of Trustees shall cease to be or be disqualified as Trustee for any reason whatsoever or in terms of foregoing provisions, it shall be lawful for the remaining or continuing trustees to fill in that vacancy from the category of the trustees so removed. The such substituted Trustees shall have terms, tenure, power and responsibilities as of the Trustee whom he replaces.

(16) The trustees for the time being, in their meeting, shall elect from amongst themselves:-

(a) A "Chairman" who shall preside all meetings of the General Body and the Board of Trustees and shall be a watchman & guide for the management and the working staff for adoption and execution of the projects and programmes of the Trust.



(b) A "Managing Trustee" (also to be known as "Director") who shall be responsible for the management and regular working of the activities of the trust with the help and assistance of the employee-staff. He will also get the accounts duly audited by qualified auditor and prepare Annual report to be placed in the Annual General meeting of the General Body after prior approval of the same by the Board of Trustees He will do so under the guidance and advises of the chairman. He will be the custodian of the Trust Fund, related documents and shall keep proper accounts of all income and expenditure himself and/or with the help of employee staff.

(c) It is provided that the Board of Trustees may assign both of the offices of the chairman and the Managing Trustee (Director) to any one of them.

(d) The tenure of the offices of the chairman, the Managing Trustee shall be for a period of three years But the retiring chairman and/or Managing Trustee shall be eligible to be re-elected for subsequent terms.

(17) MEETINGS OF THE BOARD OF TRUSTEES :-

(a) The meetings of the Board of Trustees will be held from time to time convened by the Managing Trustee as may be necessary and at least two such meetings shall be held in a year to know about the progress of the work and to take such decision as may be necessary.

(b) The Board of Trustees in meeting will frame rules of Business and to add, alter, change the same from time to time as may be considered necessary.

(c) subject to other provisions herein contained the decision by the majority of the Trustees present in the meeting shall be final and binding. In the case of a tie or equality of votes, the chairman and in his absence the presiding member number of that meeting will have casting vote extra.

(d) the quorum of the meeting of the Board of Trustees will be one-third of their total number or two whichever may be less

(e) Any resolution adopted, without any meeting of the Board but consented to by circulation among the Trustees and evidenced in writing under the signatures of at least two-third of



their total number, shall be deemed to have been passed, valid and effective as a Resolution passed in a meeting of the Board of Trustees.

(18) The Board of Trustees may, if so considered from time to time constitute committee(s) consisting of some trustees and others for specified purpose (s) and to delegate the same such powers and function as the Board may deem fit and proper. The decision(s) of such committee (s) shall be by majority of votes and such decision(s) shall be communicated to the Board through the Managing Trustee.

(19) The Board of Trustees shall have full powers for fulfilment of any or all of the objects and other affairs of the Trust generally including the following functions:-

(a) To accept or decide not to accept any membership, contribution, donations or grants in cash or Kind from any person, body of persons, Trusts, Govt. or Non Govt. organisations with or without condition(s).

(b) To apply the whole or any part of the receipts of the Trust, or the Trust fund or accumulations thereto, to any one or more of the objects of the Trust, as the Trustees may, in their discretion deem fit from time to time.

(c) To convert and deal with Trust property and/or any investment for the time being.

(d) To invest the Trust Fund either in immovable property (ies) or in debentures or other securities and investments or in deposits with any Bank or any other bodies, and to alter, vary or transpose such investments, from time to time, at the discretion of the Trustees and/or to invest the moneys belonging to the Trust fund and all surplus money in the manner above mentioned or in any other manner decided by the Board of Trustees but not in violation of any of the terms of these presents or any law for the time being in force, in their absolute discretion they may think fit and proper

(e) To borrow or raise or secure payments of money due to the trust.

(f) To sell, dispose of, alienate or otherwise deal with any property or fund of the trust.

(g) To let out, demise any movable property comprised in the Trust fund for such period and at such rent, on such terms and conditions as the trustees in their discretion may think fit and/or to take on hire or rent any property to carry out the objects of the trust on such terms and conditions as the Trustees may deem fit & proper.
