

Conditions for which compliance to be submitted+ within three months of issue of sanction letter:-

- 1. Running starting of Class IX/X & XI/XII without prior Provisional Affiliation upto Secondary level/Sr. Secondary level from the Board would be unauthorized classes and school shall be responsible for the consequences arising out of it.
